

Case Study

ERP Implementation

Background:

The client had multiple business lines each with their own back-office, set of processes, procedures, and systems that did not integrate with each other or the main corporate office. Many of these operations were run on outdated mainframe platforms. The client had strategic goals that included upgrading its F&A capabilities to both capture current functionality improvements and provide a scalable platform that could integrate acquisitions as part of their strategic growth goals.

Challenges included developing a robust enough solution that balanced the need for commonality and consistency across the disparate business models with ensuring that each business could leverage the solution to their needs. This required a very high level of communication and coordination across all stakeholders and the complete rebuilding of how the F&A teams worked both internally and with the operations.



Results:

As members of the project leadership team we successfully worked with all stakeholders to lead the company development of an entirely new, common set of processes, procedures, and system configuration. Additionally, we led in the facilitation of change management identification, communication and training development for users and impacted stakeholders. This 18 month, multimillion dollar project went live on time and on budget. Functionality was operational within days of cutover and improvements were being recognized by the time of the first month end closeout.
